**Presentation Summary:** This presentation elucidates the structural disproportionate reality of homicide victimization for Black people by highlighting the root causes and consequences of experiencing chronic cumulative Black death. This presentation invites participants to engage in embracing a fundamental paradigm shift in the way we think, define, assess, and respond to death, dying and bereavement for Black survivors of homicide victims. This keynote is designed to not only inform but also inspire researchers, policymakers, and practitioners on pathways for understanding the ways we should support and provide services to Black survivors of homicide victims.
